ORDER

No. 1274—Ele.(ML)-65 & 126/2010-SEC. —Whereas, Executive Officer, Vyasaganar Municipality vide his letter No. 05, dated the 2nd January 2010 and Executive Officer, Koraput N.A.C. vide his letter No. 06, dated the 2nd January 2010 have reported that a casual vacancy in Office of the Councillor of Ward No. 04 of Vyasaganar Municipality has occurred due to death of the Councillor and Ward Nos. 09 & 13 of Koraput N.A.C. have occurred due to resignation of the Councillors;

And whereas, the revision of Electoral Roll of Vyasaganar Municipality and Koraput N.A.C. has been completed by the Election Officer concerned;

Now, therefore, the State Election Commission in exercise of powers conferred under Section 45 of Orissa Municipal Act, 1950 read with Rule 77(2) and Rule 23(2) of The Orissa Municipal (Delimitation of Wards, Reservation of Seats and Conduct of Election) Rules, 1994 hereby appoints following Schedules, dates and time to conduct by-election to the office of Councillor of Ward No. 04 of Vyasaganar Municipality and Ward Nos. 09 and 13 of Koraput N.A.C.
