No. 21199—ISME-G-3/2008-SME.—The following officers of Orissa Elementary Education Service, Level-II Cadre are temporarily promoted on *ad hoc* basis in Orissa Elementary Education, Level-I and posted as District Inspector of Schools /A.A.O. as mentioned below in the Pay Band of PB-2 Rs. 9,300—34,800 with Grade Pay Rs. 4,600 for a period of one year or till the appointment is made in consultation with Orissa Public Service Commission, Cuttack or till the retirement of officers whichever is earlier.
