ORDER

No. 2162—Ele.(ML)-46/2010-SEC. —Whereas, the Municipal Commissioner, Berhampur Municipal Corporation vide his letter No. 969, dated the 3rd February 2010 has reported that a casual vacancy in office of the Corporator of Ward No. 16 of Berhampur Municipal Corporation has occurred due to resignation of the Corporator;
