**S.R.O. No. 221/2010**—Whereas, Executive Officer, Jeypore Municipality vide his Letter No. 612, dated the 26th February 2010 and Letter No. 1046, dated the 8th April 2010 and Executive Officer, Balugaon N.A.C. vide his Letter No. 361, dated the 3rd February 2010 have reported that a casual vacancy in the office of Councillor of Ward Nos. 10 and 24 of Jeypore Municipality and Ward No. 04 of Balugaon N.A.C. have occurred due to death of the Councillors;

And whereas, the revision of Electoral Roll of Jeypore Municipality and Balugaon N.A.C. has been completed by the Election Officer concerned.

Now, therefore, the State Election Commission in exercise of powers conferred under Section 45 of Orissa Municipal Act, 1950 read with Rule 77(2) and Rule 23(2) of The Orissa Municipal (Delimitation of Wards, Reservation of Seats and Conduct of Election) Rules, 1994 hereby appoints following Schedules, dates and time to conduct by-election to the Office of Councillor of Ward Nos. 10 and 24 of Jeypore Municipality and Ward No. 04 of Balugaon N.A.C.
