NOTIFICATION

The 5th June 2010

S.R.O. No. 237/2010—In exercise of the powers conferred under Section 33 of the Orissa Forest Act, 1972 (Orissa Act 14 of 1972), the State Government do hereby declare that the following land situated in village Kalanda (Kha) under Telkoi Tahasil of the district of Keonjhar mutated and transferred for compensatory afforestation purpose against the approved diversion of forest land for Thakurani Iron Mines of M/s Sarda Mines Private Limited vide Order No. 8—55/2000-FC., dated the 21st June 2001 of Government of India, Ministry of Environment & Forests under Section 2 of the Forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 94.4965 Ha. shall be Protected Forests with effect from the date of issue of the Notification and shall be known as “Kalanda (Kha) Protected Forest” :—
