SUBJECT : Notification under Section 6 of the Delhi Special Public Establishment (D.S.P.E.) Act, 1946.

No. 9165-PR.—In view of the fact that the Hon'ble Supreme Court has directed Government of India to ensure that the Central Bureau of Investigation (C.B.I.) investigates the alleged violation of M.G.N.R.E.G.A., as intimated by Secretary to the Ministry of Rural Development vide his D.O. Letter No. L-12060-2-2008-MGNREGA(Pt.), dated the 13th April 2011, the Government of Orissa issues this notification for an investigation by C.B.I., on the alleged irregularities as mentioned in the Annexure A of the Writ Petition No. 665 of 2007, which is titled "Rural Job Scam Survey Report on implementation of N.R.E.G.A. in Orissa", vide Para. 2 of the reference made by Government of India to the C.B.I. in their letter No. L-12060-2-2008-MGNREGA(Pt.), dated the 4th April 2011 as per details given below:

Writ Petition No. 645 of 2007 was filed by the petitioner enclosing a survey report as Annexure A which is titled "Rural Job Scam-survey report on implementation of N.R.E.G.A. in Orissa" which is a survey of performance of N.R.E.G.A. in 100 villages of 6 districts in Orissa for the year 2006-2007. This survey was conducted during May-June 2007 by Delhi-based Centre of Environment and Food Security (C.E.F.S.) to assess and evaluate the performance of National Rural Employment Guarantee Scheme (N.R.E.G.S.) in the State of Orissa.

This survey alleged to have detected irregularities in implementation of N.R.E.G.A.

in those 100 villages of 6 districts for the year 2006-2007. Hon'ble Supreme Court has directed Government of India to ensure that the Central Bureau of Investigation (C.B.I.) investigates the alleged violation of M.G.N.R.E.G.A., as intimated by Secretary to the Ministry of Rural Development vide his D.O. Letter No. L-12060-2-2008-M.G.N.R.E.G.A.(Pt.), dated the 13th April 2011, the Government of Orissa. The survey was carried out in 100 villages spread over six districts of K.B.K. (Kalahandi-Balangir-Koraput) region, namely; Balangir, Nuapada, Kalahandi, Koraput, Nabarangpur and Rayagada.
