RESOLUTION

The 18th August 2011

At present the Common Cadre Audit Organisation is having cadre strength of 64 (sixty-four) Assistant Audit Officers (as redesignated in Finance Department Resolution No. 35727-F., dated the 18th August 2011 for review and supervision work of 409 (four hundred nine) Auditors. In the present scenario, Common Cadre Auditors are stagnating in the same post for more than 20 years. With a view to providing better promotional avenues and to ensure effective supervision of audit works, the cadre strength of Assistant Audit Officers needs revision.

After careful consideration, Government have been pleased to upgrade 50 (fifty) posts of 'Auditors' of Common Cadre Auditor Organisation in the Pay Band-2 with Pay Scale of Rs. 9,300 to Rs. 34,800 and Grade Pay Rs. 4,200 to the rank of Assistant Audit Officers in the same Pay Band with the same Scale of Pay and Grade Pay.

Due to upgradation of 50 (fifty) posts of 'Auditors' to the rank of Assistant Audit Officer, equal No. of posts of Auditors stand abolished at the base level reducing the cadre strength of Auditors to 359. After upgradation and abolition, the reallocation of 'Auditors' and 'Assistant Audit Officer' in different Administrative Departments is given as under—
