SUBJECT—Restructuring the Cadre of Orissa Co-operative Service

The proposal relating to restructuring the Cadre of the Orissa Co-operative Service has been engaging the attention of the Government for sometime past. After careful consideration, the State Government have decided as follows :

1. Over the years, the importance of the Cadre has increased to a great extent due to implementation of different schemes such as Crop Insurance, Marketing of Agricultural inputs, Paddy Procurement, Agricultural Marketing, Promotion of Self-Help Groups & Self-Help Co-operatives. The Cadre of O.C.S. has not been restructured since its inception. In order to strengthen the Co-operative movement and to bring the Co-operative Institutions closer to the people, it is necessary to re-organise the existing Divisions and Circles under the hierarchy of Co-operation Department and also to restructure the Cadre of O.C.S.

2. Presently the Co-operative Tribunal, Orissa is functioning with one member from the Orissa Superior Judicial Service (Senior Branch). There are large number of cases pending for disposal in the Co-operative Tribunal. Hence the Tribunal is required to be reconstituted with 2nd Member for expeditious disposal of cases. The 2nd Member in the rank of Special Secretary shall be filled up from O.C.S. Cadre carrying the Scale of Pay of Rs. 37,400–67,000 (Pay Band-4) with Grade Pay Rs. 9,000.

3. The post of Joint Secretary in Co-operation Department meant for the cadre of OAS has been upgraded to the rank of Additional Registrar of Co-operative Societies-*cum*-Additional Secretary to Government as per Co-operation Department Order No. 12401, dated 30-11-2010 with concurrence of Finance Department and approval of the Chief Minister. The Scale of Pay of the post of Additional Registrar of Co-operative Societies is upgraded to the scale of pay of Rs. 37,400—67,000 (Pay Band-4) with Grade Pay Rs. 8,700 with effect from the 30th November 2010.

4. One post of Joint Secretary shall be created in the Co-operation Department in the O.C.S. Cadre for smooth functioning of the Department by restoring the post of Joint Secretary meant for O.A.S. Cadre. The post of Joint Secretary shall be filled up from O.C.S. Cadre carrying Scale of Pay of Rs. 15,600—39,100 (Pay Band-3) with Grade Pay Rs. 7,600.

5. Four new Co-operative Divisions shall be created one each in the district of Khurda, Angul, Baragarh and Rayagada having more than one Subdivisions. In addition two more new Divisions, i.e. Cuttack-II and Sambalpur-II Division shall be created. The Cuttack-II Division shall cover Jajpur, Jagatsinghpur and Kendrapara Districts and Sambalpur-II Division shall cover Deogarh and Jharsuguda District.

The number of Co-operative Divisions will be raised from 13 to 19 by creation of 6 new Divisions and 6 more posts shall be created in Divisional DRCS in the Scale of Pay of Rs. 15,600—39,100 (Pay Band-3) with Grade Pay Rs. 6,600. The other supporting staff to these new 6 offices will be provided from the parent division by way of redeployment.

6. Eleven numbers of Co-operative Circle shall be created in the Subdivisions of Nilagiri, Kaptipada, Hindol, Athamallik, Patnagarh, Biramaharajpur, Rairakhola, Champua, Bonai, Jharsuguda and Deogarh. After creation of the above new circles the number of circles will be raised from 47 to 58. Thus 11 numbers of Assistant Registrar of Co-operative Societies shall be created carrying the Scale of Pay of Rs. 9,300—34,800 (Pay Band-2) with Grade Pay Rs. 4,600 in the cadre of Orissa Co-operative Service.

7. The Cadre strength of restructured grade of O.C.S. will be as in the Annexure.

8. The Finance Department have concurred in the Draft Cabinet Memorandum vide their U & R. No. 3219/PSF, dated 6-6-2011.

9. This has the approval of the Cabinet in their 17th Meeting held of 16th August 2011.

10. Any amendments to or formulation of the rules regulating recruitment to the restructured O.C.S. Cadre shall be finalized in the prescribed manner within six months.

11. This will come into force with immediate effect.
