NOTIFICATION

The 29th September 2011

S. R. O. No. 916/2011 —In exercise of the powers conferred under Section 33 of the Orissa Forest Act, 1972 (Orissa Act 14 of 1972), the State Government do hereby declare that the non-forest land situated in Village Tukuguda under Thuamul-Rampur Tahasil of the district of Kalahandi mutated and transferred for compensatory afforestation purpose in favour of Divisional Forest Officer, Kalahandi (South) Division against the approved diversion of forest land in Pariagarh Reserved Forest of Kalahandi (South) Division and in village forests of Kalahandi District, Orissa for Lanjigarh Road-Junagarh Broad Gauge (BG) Railway Line of South-Eastern Railway in Kalahandi District vide Government of India, Ministry of Environment and Forests in their Letter F. No. 8-22/1996-FC, dated the 13th November 2009 under Section 2 of the Forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 48.25 Ha. shall be Protected Forests with effect from the date of issue of the Notification and shall be known as "Tukuguda-A Protected Forest" .
