No. 18067—10F-(Cons) -238/2011(pt.)-F&E.— In pursuance of the order of Hon'ble Supreme Court of India dated the 10th July 2009 in IA NO. 2143 in W.P. (C) No. 202/1995 approving/accepting guidelines and composition of the State Compensatory Afforestation Fund Management and Planning Authority (State CAMPA) suggested by the Government of India, MoEF dated the 2nd July 2009, the State Government have already constituted an authority known as "State Compensatory Afforestation Fund Management and Planning Authority, Orissa (State CAMPA, Orissa)" vide their Notification dt. 13995/F&E., dated the 14th August 2009 (read with Notification No. 9444/F&E., dated the 24th May 2010 and No. 4597/F&E., dated the 14th March 2011) indicating details of its aims and objectives, the composition of the Governing Body, Steering Committee and Executive Committee of the State CAMPA with their functions.

As per provisions of the State-CAMPA guidelines, two eminent Non-Government Organizations (NGOs) were inducted by the State Government as Members of the Executive Committee of the State CAMPA for a period of two years i.e. 2011–12 and 2012–13 and the same was indicated vide Para 5.3 of the F&E Department Notification bearing No. 4597/F&E., dated the 14th March 2011. The State Government, taking note of the change occurred at the level of Executive Director, VASUNDHARA (NGO), have been pleased to nominate the Executive Director, VASUNDHARA (NGO), as a Member of the Executive Committee of the State-CAMPA for the period up to the end of the year 2012–13 (F.Y) in place of earlier nomination made in F&E., Department Notification No. 4597/F&E., dated the 14th March 2011.

In view of the above changed nomination of NGO member, the composition of the Executive Committee, State-CAMPA shall be as follows :
