ORDER

The 15th October 2011

No. 4647-SEC.—Whereas, it is reported by the Executive Officer, Bhuban NAC that casual vacancy in the Office of Chairperson of Bhuban NAC has occurred due to No Confidence Motion moved against Chairperson through Bhuban NAC Council Resolution on 10-11-2010 ;

Whereas, the Government in Housing & Urban Development Department vide Notification No. 27289, Dt. 29-9-2011 have published the said Council Resolution ;

Whereas, it is necessary to conduct by-election to fill up the said casual vacancy ;

Now, therefore, in exercise of powers conferred under Section 49 of The Orissa Municipal Act, 1950 and Rule 68 of The Orissa Municipal (Delimitation of Wards, Reservation of Seats and Conduct of Election) Rules, 1994, the State Election Commission appoints following dates for holding of election to fill up the aforesaid casual vacancy. The result of the by-election shall be subject to the final decision on the Review Petition bearing RVWPET No. 152 of 2011.
