No. 6040—(ML)-49/2011-SEC.—Whereas, it is reported by the Executive Officer, Chatrapur N.A.C. that casual vacancy in the office of Vice-Chairperson of Chatrapur N.A.C. has occurred due to resignation of the Vice-Chairperson on the 26th September 2011;
