NOTIFICATION

The 16th March 2011

S.R.O. No. 123/2011—In exercise of the powers conferred under Section 33 of the Orissa Forest Act, 1972 (Orissa Act 14 of 1972), the State Government do hereby declare that the land situated in village Balibahala under Pallahara Tahasil of the district of Angul mutated and transferred for compensatory afforestation purpose against the proposed diversion of forest land for M/s Utkal Coal Limited Project of Coal Mining vide Government of India, Ministry of Environment & Forests orders in their in-principle approval letter F. No. 8—25/2010-FC., dated the 8th October 2010 under Section 2 of the Forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 149.0094 Ha. shall be Protected Forests with effect from the date of issue of the Notification and shall be known as “Balibahala Protected Forest”.
