ORDER

The 18th April 2011

No. 1361-Ele. (ML)-6/2011-SEC.—Whereas it is reported by the Executive Officer, Kamakhyanagar N.A.C. that casual vacancy in the office of Vice-Chairperson of Kamakhyanagar N.A.C. has occurred due to No Confidence Motion passed against the Vice-Chairperson on the 24th January 2011;

Whereas the Government in H. & U.D. Department vide Notification No. 8275, dated the 24th March 2011 have published the said Council Resolution;

Whereas it is necessary to conduct by-election to fill up the said casual vacancy.

Now, therefore, in exercise of powers conferred under Section 49 of the Orissa Municipal Act, 1950 and Rule 69 of the Orissa Municipal (Delimitation of Wards, Reservation of Seats and Conduct of Election) Rules, 1994, the State Election Commission appoints following dates for holding of election to fill up the aforesaid casual vacancy.
