NOTIFICATION

S. R. O. No. 289/2012—In exercise of powers conferred under Section 4 of the Odisha Forest Act, 1972 (Odisha Act 14 of 1972), the State Government in Forest & Environment Department do hereby propose to constitute the following schedule of forest/non-forest land situated in Villages Kendughati, Kucheita and Kusumtola under Bonai Tahasil of the District of Sundargarh, mutated and transferred for compensatory afforestation purposes against the proposed diversion of forest land of 238.447 Ha. in Patamunda, Podadihi village and Khajuridihi PRF under Bonai Tahasil of Sundargarh district for Manganese Ore Mining by M/s Odisha Manganese and Minerals (P) Ltd. during 3rd RML vide order No. 8—92/2007-FC., 20th November 2009/the 4th December 2009 (read with corrigendum No. 8—92/2007-FC., dated the 1st January 2010) of Government of India, Ministry of Environment and Forests under Section 2 of the Forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 135.63 Ha. as proposed reserved forests, with effect from the date of issue of the Notification and shall be known as “Kendughati Proposed Reserved Forests, Kucheita Proposed Reserved Forests and Kusumtola Proposed Reserved Forests”.
