ORDER

No. 7595-(ML)-8/2012-SEC.—Whereas, it is reported by the Executive Officer, N.A.C., Rambha that casual vacancy in the office of Chairperson of N.A.C., Rambha has occurred due to No Confidence Motion passed against Chairperson on 7th June 2012 ;

Whereas, the Government in H & U.D. Department, Odisha have published the said resolution in *Odisha Gazette* on 21st July 2012 ;

Whereas, it is necessary to conduct by-election to fill up the said casual vacancy ;

Now, therefore, in exercise of powers conferred under Section 49 of The Odisha Municipal Act, 1950 and Rule 68 of The Odisha Municipal (Delimitation of Wards, Reservation of Seats and Conduct of Election) Rules, 1994 the State Election Commission appoints the following dates for holding of election to fill up the aforesaid casual vacancy subject to the final decision of the Special Leave to Appeal (Civil) No. 18205 of 2012.
