RESOLUTION

SUBJECT—Revision of the Pay Scales and Grade Pays of Pay Band - 1S under O.R.S.P. Rules, 2008.

On the basis of the recommendations of the Anomaly Committee and in exercise of powers conferred under Rule 19 of O.R.S.P. Rules, 2008 Government was earlier pleased to enhance the upper ceiling of the Pay Band - 1S from 4,440 - 7,440 to 4,440 - 14,680 as per F. D. Resolution No. 29318/F. dated the 1st July 2010 with effect from dated the 1st July 2010.

On further demands of the Group-D Service Associations regarding revision of the minimum of the Scales of Pay of ₹ 4,440 − 14,680/ along with enhancement of Grade Pays under Pay Band -1S, the Anomaly Committee was pleased to submit an interim report to Government with recommendation to consider enhancement of lower ceiling of the Pay Scales of ₹ 4,440 − 14,680 along with corresponding Grade Pays under O.R.S.P. Rules, 2008.

Having regard to the recommendation of the Anomaly Committee and in exercise of powers conferred under Rule 19 of O.R.S.P. Rules, 2008, Government after careful consideration have been pleased to revise the Pay Scales of ₹ 4440–14680 under Pay Band 1S as follows:—
