ORDER

The 17th March 2012

No. 4183--(ML)-14/2012-SEC.—Whereas, it is reported by the Executive Officer, **Angul Municipality** that casual vacancy in the office of Chairperson of **Angul Municipality** has occurred due to No Confidence Motion passed against Chairperson on the 19th September 2011;

Whereas, the Government in H. & U. D. Department, Odisha have published the said Resolution in *Odisha Gazette* on the 14th March 2012;

Whereas, it is necessary to conduct by-election to fill up the said casual vacancy;
