### NOTIFICATION

**S.R.O. No.522/2013**— In exercise of the powers conferred by sub-section (1) of Section 13 read with Section 14 of the Wakf Act, 1995 (43 of 1995), the State Government do hereby establish with effect from the date of publication of this Notification in the *Odisha Gazette*, a Board of Wakfs to be called the Odisha Board of Wakfs and appoint the following Members thereof, who shall constitute the said Board, namely:—
