### NOTIFICATION

No. 18149—WCD-CW-MISC.-0199/2013-W&CD.—In pursuance of sub-sections (1) and (2) of Section 4 of the Juvenile Justice (Care and Protection of Children) Act, 2000 and its amendment in the year 2006, read with Rule 3 of Juvenile Justice (Care and Protection of Children) Odisha Rules, 2002 and its amendment rules in the year 2009, the State Government do hereby constitute the Juvenile Justice Boards in the districts for exercising the powers and discharging the duties conferred or imposed on such Boards in relation to Juveniles in conflict with law under the above-mentioned Act and Rule.

2. The Juvenile Justice Boards are constituted in the districts named below in the following manner :—

4. The appointment of any member of the committee may be terminated, after holding inquiry, by the State Government, if —
- (a) He/She has been found guilty of misuse of powers vested under this Act.
  - (b) He/She has been convicted of an offence involving moral turpitude and such conviction has not been reserved or he/she has not been granted full pardon in respect of such offence.
  - (c) He/She fails to attend the proceeding of the committee for consecutive three months without any valid reason or he/she fails to attend less than three-fourth of the sitting in a year.

5. The committee shall function as a Bench of The committee shall function as Bench of Magistrates and shall have the powers conferred by the Code of Criminal Procedure, 1973 on a Metropolitan Magistrate, or as the case may be, a Judicial Magistrate of the First Class.
6. The committee shall meet at such times and shall observe such rules of procedure in regard to the transaction of business at its meetings, as may be prescribed.
7. All previous notification relating to constitution of JJBs in respect of the above districts are hereby superseded.
