Functions of the Committee :

The functions of the Committee shall be as follows. The Committee shall—

- (i) monitor and review the suggestions given by different Central Sector Project Authorities for implementation of the projects in the State;
- (ii) sort out the problems for smooth implementation of the Central Sector Projects and issue appropriate directions to the appropriate State Authorities;
- (iii) discharge such other tasks as may be assigned to it by the State Government or Government of India;
- (iv) meet as and when required.

ORDER—Ordered that the Resolution be published in an extraordinary issue of the *Odisha Gazette*/be displayed in Website of State Portal Group, NIC, Secretariat.
