NOTIFICATION

The 27th April 2013

S.R.O. No. 319/2013—In exercise of the powers conferred under Section 33 of the Odisha Forest Act, 1972 (Odisha Act 14 of 1972), the State Government do hereby declare that the following land situated in village Jatra under Bansapal Tahasil of the district of Keonjhar mutated and transferred for compensatory afforestation purpose against the proposed diversion of forest land for Gandhamardan Block-A Iron Ore Mines of M/s Odisha Mining Corporation Ltd. vide Government of India, Ministry of Environment & Forests, letter in their in-principle approval Order F.No. 8-105/2006-FC., dated the 17th February 2009 under Section 2 of the Forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 117.9648 ha shall be Protected Forests with effect from the date of issue of the Notification and shall be known as “Jatra Protected Forest”.
