NOTIFICATION

Whereas, the Commission had approved the schedule for Special Summary Revision of Electoral Rolls with reference to the 1st January 2013 as the qualifying date in the State of Odisha with period for filing claims and objections from the 8th April 2013 to the 7th May 2013 vide its Letter No. 23/OR/2013, dated the 18th February 2013 ; and

Whereas, the Commission has received a request from the Chief Electoral Officer, Odisha vide her Letter No. 4928—IE(A)-06/2013-Elec., dated the 6th May 2013 for extending the period for House to House Campaign in respect of Five Assembly Constituencies of 112-Bhubaneswar (Central), 113-Bhubaneswar (North), 114-Ekamra Bhubaneswar, 90-Barabati-Cuttack and 91-Choudwar-Cuttack till the 14th May 2013 because of the peculiar problems being faced by the BLOs. and public due to prevailing heat wave ; and

Whereas, the Commission has considered the request and has decided to extend the period for filing claims and objections by the 21st May 2013 vide Commission's Notification, dated the 7th May 2013 which will also give more time for House to House verification ; and

Whereas, the Commission has again received a request from Chief Electoral Officer, Odisha vide her Letter No. 5070—IE(A)-6/2013-Elec., dated the 16th May 2013 for further extension of time in the revision of programme so as give more time for collecting photos from residual electors and for public to file claims and objections ; and

Whereas, the Commission has considered the request and has decided to further extension the period for filing claims and objections by ten days; and

Now, therefore, the Election Commission, in exercise of power conferred by proviso to Rule 12 of Registration of Electors Rules, 1960 extends for all Assembly Constituencies in State of Odisha, the period for filing claims and objections up to the 31st May 2013 (Friday) for ongoing Special Summary Revision of Electoral Rolls with reference to the 1st January 2013.
