NOTIFICATION

The 1st July 2014

S.R.O. No. 282/2014—In exercise of the powers conferred under Section 33 of the Odisha Forest Act, 1972 (Odisha Act 14 of 1972), the State Government do hereby declare that the following land situated in Village Kanaka under Hindol Tahasil of the District of Dhenkanal mutated and transferred in favour of Forest Department for compensatory afforestation purposes against the proposed diversion of forest land for Sarkunda Iron and Manganese Mines of M/s Feegrade & Co. (P) Ltd. in Bonai Forest Division of Sundargarh District of Odisha vide Stage-I Forest Clearance Order F. No. 8-51/2011-FC., dated the 28th October 2013 of Government of India, Ministry of Environment and Forests under Section 2 of the Forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 510.25 Acres or 206.49 Ha. shall be Protected Forests with effect from the date of issue of the Notification and shall be known as “Kanaka Protected Forest”.
