No. 3922-SEC.—Whereas, Executive Officer of Paradeep Municipality has reported about occurrence of casual vacancy in the office of Councillor of Ward No. 7 of Paradeep Municipality due to death vide letter No. 1280, dated the 19th March 2014;

And whereas, the revision of Electoral Roll of Paradeep Municipality has been completed by the Election Officer concerned.
