The Committee will monitor and review the following issues and recommend appropriate actions :—

- (i) Overall progress on I.C.D.S.
- (ii) Convergence with the Departments/Programmes
- (iii) Coverage in general and specifically of S.C./S.T./Minority habitations/beneficiaries against the surveyed population.
- (iv) Other issues relating to programme implementation and actions thereon.
- (v) Improving the AWC Infrastructure : Construction of AWC buildings by leveraging funds from under different Schemes/Programmes, such as BRGF, MSDP, MPLADs, etc.
- (vi) Use of IEC in creating awareness about I.C.D.S. services/health and nutrition issues and possibility of convergence with IEC activities under other Schemes/Programmes.

The Committee will also review the implementation of the Scheme SABLA, MAMTA and IGMSY, etc.

Meeting of the State Level Monitoring and Review Committee will be held once in every six months or earlier if necessary.
