ORDER

The 29th October 2014

S.R.O. No. 497/2014—Whereas, Executive Officer of Sunabeda Municipality has reported about occurrence of casual vacancy in the office of the Councillor of Ward No. 17 of Sunabeda Municipality due to resignation vide Letter No. 1592, dated the 30th June 2014 ;

And whereas, the revision of Electoral Roll of Sunabeda Municipality has been completed by the Election Officer concerned ;

And whereas, the by-election schedule issued vide Commission's Order No. 5017, dated the 8th October 2014 was cancelled vide Order No. 5057, dated the 11th October 2014 due to very severe cyclonic situation (Hudhud) as reported by the Collector, Koraput.

Now, therefore, the State Election Commission in exercise of powers conferred under Section 45 of Odisha Municipal Act, 1950, read with Rule 77 (2) and Rule 23 (2) of The Odisha Municipal (Delimitation of Wards, Reservation of Seats and Conduct of Election) Rules, 1994 hereby appoint following schedules, dates and time to conduct by-election to the Office of Councilor of the said Ward as mentioned against each :—
