ORDER

The 15th November 2014

No. 5404—Ele.-(ML)--51/2014-SEC.—Whereas, the Municipal Commissioner, Berhampur Municipal Corporation vide their letter No. 11439, dated the 30th October 2014 have reported that casual vacancy has occurred in the office of Corporator of Ward No. 26 of Berhampur Municipal Corporation due to death of the Corporator ;

Whereas, it is necessary to prepare Wardwise Electoral Roll of aforesaid Corporation for conduct of By-election and the Commission has decided that Assembly Electoral Roll published by the Election Commission of India in January 2014 and currently in force shall be the basis for preparation of Wardwise Electoral Roll;

Now, therefore, the State Election Commission in exercise of powers vested in it under Article 243 ZA of Constitution and under Section 65 of Odisha Municipal Corporation Act, 2003 read with Odisha Municipal Corporation (Division of City of Wards, Reservation of Seat and Conduct of Election) Rules, 2003 thereunder directs that Wardwise Electoral Roll of Berhampur Municipal Corporation shall be prepared as per the programme laid down in Schedule-I in the manner prescribed in Schedule-II of this order.
