S.R.O. No. 27/2014—In exercise of the powers conferred by sub-section (2) of Section 4 of the Odisha Kendu Leaves (Control of Trade) Act, 1961 and in supersession of this Department Notification No. 21563-F&E., dated the 24th November 2011, the State Government do hereby constitute the Kendu Leaves Development Board (K.L.D.B.), in place of Kendu Leaves Advisory Committee (K.L.A.C.) from the Crop Year, 2014 to advise the Government on fixation of purchase price of Kendu Leaf and on such matters as may be referred to it by Government.
