NOTIFICATION

No.1164-LC-TR-67/2013/T. Whereas the draft of certain rules further to amend the Odisha Motor Vehicles Rules, 1993 was published as required by sub-section (1) of Section 212 of the Motor Vehicles Act, 1988 (59 of 1988) in the extraordinary issue No.164., dated the 18th January, 2014 of the *Odisha Gazette* under the Notification of Government of Odisha in the Commerce & Transport (Transport) Department No.329-LC-TR-67/2013/T., dated the 18th January, 2014 inviting objections and suggestions from all persons likely to be affected thereby till the expiry of a period of fifteen days from the date of publication in the *Odisha Gazette*;

And, whereas, objections and suggestions received in respect of the said draft. Notification have duly been considered by the State Government,-.

Now, therefore, in exercise of the powers conferred by section 65 & 96 of the Motor Vehicles Act, 1988 (59 of 1988), the State Government do hereby make the following Rules further to amend the Odisha Motor Vehicles Rules, 1993, namely:—

1. (1) These rules may be called the Orissa Motor Vehicles (Amendment) Rules, 2014.

(2) They shall come into force on the date of their publication in the *Odisha Gazette*.

2. In the Orissa Motor Vehicles Rules, 1993 (hereinafter called as the said rules) in rule-39, sub-rule (1), for the words “thirty one” the words “thirty five” shall be substituted.

3. In the said rules, in First Schedule, the following words, commas, figures and letters shall be added at the end under the appropriate columns, namely:—
