STATE CO-OPERATIVE ELECTION COMMISSION, ODISHA NOTIFICATION

The 5th August, 2015

S.R.O. No. 338/2015 — In pursuance of sub-rule (1-a) of Rule 3 of the Odisha Co-operative Societies (Election to the Committees) Rules, 1992, the State Government in Co-operation Department vide Notification No. 5673 /Co-op., dated the 4th August, 2015 have fixed dated the 11th October, 2015 as the date for the election of Members to the Committee of OBC Finance & Development Co-operative Corporation Ltd. and the Committee of Odisha State Co-operative Union Ltd., Bhubaneswar on the recommendation of this Commission and have called upon the said Societies to elect members of the Committees of those Societies on the said date.

Now, therefore, in exercise of powers conferred upon the Commission under sub-section 6 & 7 of Section 28 AA of OCS Act,1962 and sub-rule (2) of Rule 3 of the Odisha Co-operative Societies (Election to the Committees) Rules,1992 , the Officers as per **Annexure** to this notification are appointed as Election Officers and Assistant Election Officers for the said Societies mentioned against them to conduct the election as per the provisions of OCS Act,1962 and OCS (Elections to Committees) Rules, 1992 subject to direction, supervision and control of the State Co-operative Election Commission until further orders.

The Election Officers so appointed are required to fix the date of election of the Co-operative Societies to the above date and publish the notification atleast two months prior to the date of election so fixed as required under sub-rule (1) of Rule 4 of OCS (Elections to the Committees) Rules, 1992.

Further, as defined under Rule 2(d) of the OCS (Election to the Committees) Rules, 1992, the Election Officer includes Assistant Election Officer and therefore, the Assistant Election Officer appointed for the Co-operative Society may discharge all or any

function of the Election Officer as per the Provisions of the OCS Act, 1962 and (Election to the Committees) Rules, 1992 and to assist the Election Officer in conduct of the Election.

The Officers/Staff/Employees appointed are required to perform their duties as assigned to them for smooth conduct of election of Co-operative Societies and deviation in this regard in any manner would attract penal provision under sub-section 11 & 12 of Section 115 of OCS Act,1962 and Rule 56 of OCS(Elections to the Committees) Rules,1992.

This notification will come into force forthwith and the same be published in the Extraordinary issue of *Odisha Gazette*.
