NOTIFICATION

The 24th September, 2015

S.R.O. No. 411 / 2015 — In pursuance of the powers conferred under Clause (b) of Section 3 of the Odisha Education Act, 1969 read with 3, 4 and 5 of the Odisha Education (Payment of Grant-in-Aid to High Schools, Upper Primary Schools etc.) Order, 2004 and subsequent amendments thereof and Odisha Education (Payment of Grant-in-Aid to High Schools, Upper Primary (M.E.) Schools, Sanskrit Tols and Madrasas) Order, 2013 the State Government do hereby notify the following Private Educational Institutions eligible to receive Grant-in-Aid as aided educational institutions with effect from the 1st October, 2015 subject to following conditions.

- (i) These Schools shall avail Grant-in-Aid prospectively as per Grant-in-Aid Order, 2013.
- (ii) There shall be no claim for retrospective benefit i.e. the benefit will be calculated from the date of sanction of Grant-in-Aid as per Notification.
- (iii) The Court cases pending on the matter shall be withdrawn before sanction of Grant-in-Aid. The school authorities shall submit undertaking in this regard.
- (iv) If the Institution or employees of the Institution will file any case in the Court after receiving the Grant-in-Aid, the Grant-in-Aid shall also be withheld till finalization of the court cases. This will be applicable to all Grant-in-Aid Schools.
- (v) The Grant-in-Aid shall be stopped from that academic year if the result of the Institution in HSC Examination falls short of 50% of the State average.
- (vi) Any teacher on being newly recruited in place of a Grant-in-Aid post due to retirement, death or otherwise shall only be filled up with due concurrence of the appropriate authority with requisite qualification or else the Grant shall not be extended to the Institution.

(vii) The Educational Institutions shall maintain proper standard of education and shall have qualified teachers and required students strength as provided under the Act, 1969.

(viii) If any institution fraudulently misrepresent facts / information, criminal action will be initiated against the said institution in addition to withdrawal of Grant-in-Aid.
