NOTIFICATION

The 16th January 2015

S. R. O. No. 26/2015—In exercise of the powers conferred under Section 33 of the Odisha Forest Act, 1972 (Odisha Act 14 of 1972), the State Government do hereby declare that the following land situated in Village Tunkhal under Dasmantapur Tahasil of the District of Koraput mutated and transferred in favour of Forest Department for compensatory afforestation purposes against the approved diversion of forest land for Bauxite Mining in Panchapatmali (Central & North) Block Mining lease of M/s National Aluminium Company Ltd. (NALCO) vide Stage - II forest clearance Order F. No. 8—40/1993-FC (Pt.-I), dated the 15th September 2014 of Government of India, Ministry of Environment & Forests and Climate Change under Section 2 of the Forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 299.42 acres (121.171ha.) shall be Protected Forests with effect from the date of issue of the Notification and shall be known as “Tunkhal Protected Forest”.
