ORDER

No. 382—Ele.(ML)-03/2015-SEC.—Whereas, the Municipal Commissioner, Berhampur Municipal Corporation vide his letter No.11439, dated the 30th October 2014 has reported that a casual vacancy in Office of the Corporator of Ward No.26 of Berhampur Municipal Corporation has occurred due to death of the Corporator ;

And whereas, the revision of Electoral Roll of Berhampur Municipal Corporation has been completed by the Election Officer, Berhampur Municipal Corporation;

Now, therefore, the State Election Commission in exercise of powers conferred under Section 59 of the Odisha Municipal Corporation Act, 2003 read with Rule 90 (2) and Rule 22 (2) of the Odisha Municipal Corporation (Division of City into Wards, Reservation of Seats and Conduct of Election) Rules, 2003 hereby appoints following schedules, dates and time to conduct by-election to the office of Corporator of Ward No.26 of Berhampur Municipal Corporation.
