### NOTIFICATION

The 29th January 2015

**S. R. O. No. 53/2015**—In exercise of the powers conferred under Section 33 of the Odisha Forest Act, 1972 (Odisha Act 14 of 1972), the State Government do hereby declare that the following land situated in village Hemgir under Hemgir Tahasil of the district of Sundargarh mutated and transferred in favour of Forest Department for compensatory afforestation purposes against the proposed diversion of forest land for construction of Railway siding and Merry-Go-Round (MGR) Railway system by M/s Odisha Power Generation Corporation Ltd in Jharsuguda and Sundargarh district of Odisha vide Stage - I forest clearance order F. No. 8—93/2012-FC., dated the 10th September 2013 of Government of India, Ministry of Environment & Forests under Section 2 of the Forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 283.42 acres or 114.70 ha. shall be Protected Forests with effect from the date of issue of the Notification and shall be known as “Sukhabandha Protected Forest” :—
