### NOTIFICATION

The 12th March 2015

**S. R. O. No. 111/2015**—In exercise of the powers conferred under Section 33 of the Odisha Forest Act, 1972 (Odisha Act 14 of 1972), the State Government do hereby declare that the following land situated in village Durubaga under Hemgir Tahasil of the district of Sundargarh mutated and transferred in favour of Forest & Environment Department for compensatory afforestation purposes against the approved diversion of Forest land for Manoharpur Coal Mines of M/s Odisha Power Generation Corporation Ltd. in Sundargarh district of Odisha vide Stage - II forest clearance Order F. No. 8—63/2011-FC., dated the 20th August 2014 of Government of India, Ministry of Environment & Forests & Climate Change under Section 2 of the Forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 67.18 acres or 27.18 Ha. shall be Protected Forests with effect from the date of issue of the Notification and shall be known as “Durubaga Protected Forest” :—
