No. 2625—IV-LR(S)-12/2015-L.—Government after careful consideration and in supersession of the Notification of Government of Odisha issued in Law Department No. 9537—I-LR-23/2012-L., dated the 31st August 2012 have been pleased to determine the Fee Structure of Advocate-On-Record engaged in Supreme Court of India and other charges as follows :—

1	Expenses for filing of SLP including Court Fees & Misc. Petitions. The fees shall be borne by A/D after obtaining necessary concurrence from Law Department as per rule.	Rs. 10,000

3	For filing separate in SLP in bunch cases against the judgement of Hon'ble High Court.	First case Rs. 9,000 each of the other case Rs. 4,500.
4	Expenses for defending SLP including filing of Rejoinder & all Misc. Petitions. The fees shall be borne by the concerned A/D after obtaining necessary concurrence of Law Department as per rules.	Rs. 9,000
5	Consolidated fees of arguing the SLP either from the side of Appellant or Respondent irrespective of number of cases, i. e. single or bunch of cases tagged together. The fees shall be borne by Law Department with the condition that the A. O. R. shall furnish the Xerox copy of relevant order of engagement made to him and detailed bills duly signed over Revenue Stamp along with the copy and the certified copy of final judgement passed by the Hon'ble Supreme Court in the relevant case/cases in which the A. O. R. is engaged.	Rs. 8,000
