NOTIFICATION

The 31st March 2015

No. 1858—Ele.(ML)-02/2015/SEC.—Whereas, the State Election Commission has issued Notification for General Election to 09 (Nine) Urban Local Bodies vide Notification No. 1024-S.E.C., dated the 3rd March 2015 including General Election of Ranpur N.A.C. of Nayagarh District;

And whereas, election process is in progress in the aforesaid nine Urban Local Bodies;

And whereas, District Magistrate, Nayagarh vide Letter No. 968, dated the 31st March 2015 has reported that the Election Officer of Ranpur N.A.C. has published the reservation status of Wards wrongly vide notice issued by him on the 10th March 2015 for which the election process has been vitiated;

Now, therefore, in exercise of the powers conferred under Article 243-ZA of the Constitution of India the State Election Commissioner being satisfied that the election process in respect of Ranpur N.A.C. is vitiated, do hereby cancel the said notification issued vide Notification No. 1024, dated the 3rd March 2015 in respect of Ranpur N.A.C. only. Accordingly the action of the Election Officer of Ranpur N.A.C. subsequent to the said notification of the Commission is hereby cancelled;

Now, therefore, in exercise of the powers conferred under Article 243-ZA of the Constitution of India, Section 11-A of Odisha Municipal Act, 1950 and Rule 23 (1) of the Odisha Municipal (Delimitation of Wards, Reservation of Seats and Conduct of Election) Rules, 1994, the State Election Commission do hereby appoint the following dates and time afresh in respect of Ranpur N.A.C. of Nayagarh District relating to the said election.
