ORDER

The 25th April 2015

S. R. O. No. 208/2015—In exercise of the powers conferred under sub-section (1) of Section 31 of the Odisha Co-operative Societies Act, 1962 (Odisha Act 2 of 1963) and in supersession of all the orders/notifications of the Government of Odisha issued from time to time in this regard, the Government in Co-operation Department do hereby specify the authorities mentioned in Column (2) of the Schedule below, who shall provide a panel of names not exceeding four persons having experience in the field of Banking, Management, Finance or specialisation in any other field relating to the objects and activities undertaken by the Societies, so that the Societies shall co-opt. any two persons from the panel of names to be the members of the Committee of Management of the Co-operative Societies mentioned in Column (3) of the said Schedule, on its behalf under sub-section (1) of Section 31 of the said Act until further orders :
