RESOLUTION

The 13th May, 2015

SUB: Guidelines and procedure for admission of students into Model Schools (Odisha Adarsha Vidyalaya) in the State of Odisha.

To make qualitative secondary education available, accessible and affordable to rural students of the State, there is a need for establishment of high quality schools for talented rural children who have no access to quality schools in Urban areas. Keeping this in view, the Government have decided to establish Model Schools (Odisha Adarsha Vidyalaya) in each Block of the State.

Initially, the Government has decided to open of 111 Model Schools (Odisha Adarsha Vidyalaya) in the selected 111 Educationally Backward Blocks (EBBs) in the State from the academic session 2015-16 in a phased manner.

During the first year, Classes VI to VIII will be opened in English Medium with co-education. Hence, the children of the parents ordinarily residing Block or studied in the particular Block in any recognized institution shall become eligible for admission into the Model Schools.

Government have been pleased to prescribe the following guideline to be followed for admission of students in model School (Odisha Adarsha Vidyalaya).

## 1. Strength:

Admission in classes VI to VIII shall be done during 2015-16 with following strength:

#### 2. Reservation:

- Seats in each class shall be reserved for admission of candidates belonging to the SCs and STs as per the percentage of population of the respective Block.
- II. Physically Challenged students 3% (in reservation group of the students)
- III. 50% seats are to be reserved to Girls in each category. In case of non-availability of student in any category, the vacancies shall be transferred as follows and filled up accordingly.

In case there is any unfilled seats reserved for girls, the same shall be filled by boy student of the respective category.

#### 3. Procedure of admission:

- a. Admission for classes VI, VII, VIII shall be done as per the provisions of RTE Act
- b. The Model school society/Mission shall prepare a model advertisement for admission into Model Schools for classes (VI to VIII year 2015-16) in English Medium duly keeping the format of application, documents required such as certificate in support of date of birth & class in which he/she reading from the concerned headmaster of the school and residential certificate from concerned Sarapanch/Councillor/Corporator and will supply to all districts along with calendar of activities. The DEOs shall inform the public through news item and advertisement as the case may be.
- c. The printed application forms for admission into schools will be made available at the Principals Office / HMs of identified schools and will be issued at the Cost to the applicants.
- d. The filled in applications along with enclosures as mentioned in the advertisement shall be received by the Principal of the Model School (Odisha Adarsha Vidyalaya) of the Block with proper receipt till the notified cut of date.
- e. The Principal of the Model School(Odisha Adarsha Vidyalaya) of the Block will register the applications received and assign registration No. in seriatim till the cut of time and date and then segregate them to prepare class wise and reserved community wise list of applicants.
- f. The list of applicants class wise and reserved community wise will be placed before the selection committee.

g. The selection of the students will be made through a committee formed under the Chairmanship of Principal at the school level. The constitution of the committee shall be as follows:

i. Principal of the School - Chairman.

ii. BDO or his representative - Member

iii. Block Education Officer of the Block - Member

iv. Senior most Teacher in charge of admission - Member Convenor

v. Two Parents to be selected by Principal - Member

vi. One Public Representative to be

nominated by the panchyat samiti - Member

- h. The Committee will draw the lots in presence of parents/ public representative to ensure complete transparency in selection of students for admissions.
- i. While preparing the select list, a waiting list of 20% seats also shall be prepared and candidates will be admitted in the order from the wait list for the left over vacancies of the selection lists.
- j. The select lists and waiting lists will be displayed at BEO spoffice and in the school premises after completion of selection process by the Committee.
- k. The Collector as the Chairman of Management Committee can allot 2 seats per class over and above the sanctioned strength for the wards of the employees of Model Schools (Odisha Adarsha Vidyalaya) in exceptional cases to provide opportunities to deprived/deserving children.
- I. The Principal of the Model School (Odisha Adarsha Vidyalaya) of the Block shall take steps to admit selected students duly verifying the certificates and maintain Admission and Withdrawal Register for the School.
- m. In case of any dispute in admission, the decision of the Collector and Chairman of Management Committee for Model Schools (Odisha Adarsha Vidyalaya) shall be final.
- 4. The State Project Director, Model School (Odisha Adarsha Vidyalaya) Society/Mission shall take appropriate action for smooth conduct of admission.
