### NOTIFICATION

The 20th May, 2015

**SUBJECT:—Merger of Directorate of Mass Education with Director, Elementary Education.**

No.9967. VI-SME-(B)21/2015/SME. On the basis of approval of Cabinet dated the 24th May, 2006 and recommendation of the Implementation Committee, reorganization of S&ME Department at District Level and Block Level has been given effect vide notification No.11940, dated the 18th May, 2013. As per the said re-organisation, the District Level Offices of Mass Education have already been merged with respective District Education Offices and the staffs have already been adjusted therein. The District Education Officer is presently looking after the work relating to Mass Education at district level.

2. Merger of Directorate of Mass Education with Directorate of Elementary Education is felt necessary only due to reduction of workload in the Directorate of Mass Education. Besides, separate field offices of Mass Education are no more in existence. Government have therefore, decided to merge Directorate of Mass Education with Directorate of Elementary Education and after merger it will function as a wing of Directorate of Elementary Education with following staff position:-
