No.318/CS/2/2016(1):-Whereas,the President of India has,by notification issued under section-12 of the Representation of the People Act,1951(43 of 1951) and published in the Gazette of India on 24th May,2016, been pleased to call upon the elected members of each of the legislative Assemblies of the States ,specified in Column (1) of the TABLE below, to elect to the Council of States,the number of members specified against that state in column (2) of the said TABLE:

Now, therefore, in pursuance of sub-section(1) of section 39 & section 56 of the said Act, the Election Commission of India hereby—

(A) appoints, with respect to the said election;

- (a) the 31st May, 2016 (Tuesday), as the last date for making nominations;
- (b) the 1st June, 2016 (Wednesday), as the date for the scrutiny of the nominations;
- (c) the 3rd June, 2016 (Friday), as the last date for the withdrawal of candidatures;
- (d) the 11th June, 2016 (Saturday), as the date on which a poll shall, if necessary, be taken; and
- (e) the 13th June, 2016 (Monday), as the date before which the election shall be completed; and

(B) Fixes the hours from 9:00 A.M to 4:00 P.M. as the hours during which the poll shall, if necessary, be taken in all the above mentioned states on the date specified above for the election.
