No. 337/2017— Whereas it has been brought to the notice of the Commission by the Chief Executive of Cargo Handling Co-operative Canteen Ltd., Paradip Port under Jagatsinghpur Circle vide his Letter No.20, dated the 8th June, 2017 and Letter No.10, dated the 27th March, 2017 of Vice President of the Society and vide Letter No.1124, dated the 4th July, 2017 of the ARCS, Jagatsinghpur Circle that, Shri Adikanda Mohanty a committee member of Constituency No.13(UR) as well as the President, Shri Srinibas Sahoo committee member of Constituency No.6(OBC/SEBC), Shri Surendra Baral committee member of Constituency No.4(UR) and Shri Dhruba Ch. Mohanty committee member of Constituency No.5(UR) of Cargo Handling Co-operative Canteen Ltd., Paradip Port have retired from their services on dated the 29th February, 2016, dated the 30th November, 2015, dated the 31st March, 2017 and dated the 31st March, 2017 respectively and as such the seats are lying vacant. It has been requested to fill up the vacancies in the office of the Committee and the post of President of the Society arising by reason of retirement.

Now, therefore, it is ordered that the vacancies in the office of members in Constituency No.13 (UR), Constituency No.6 (OBC/SEBC), Constituency No.4 (UR) and Constituency No.5 (UR) of Cargo Handling Co-operative Canteen Ltd., Paradip Port shall be filled up in the same manner as it was originally filled up as required U/S 28 (6) of OCS Act, 1962.

Shri Jogendra Nath Biswal, S.A.R.C.S.,O/o the ARCS, Jagatsinghpur Circle is hereby appointed as the Election Officer to conduct the election of office of members of Constituency No.13 (UR), Constituency No.6(OBC/SEBC), Constituency No.4(UR)and Constituency No.5(UR) of the above Society with a direction to take up the election programme for the said Constituencies by publication of the schedule of election from the stage of filing of nomination so as to conduct the poll, if necessary, on **dated the 27th August, 2017** by following the due procedure as prescribed in the OCS Act, 1962 & OCS (Elections to the Committees) Rules, 1992 and Circulars/Guidelines issued by this Commission from time to time.

He is also to take up election programme for the post President thereafter fixing poll date, if necessary, following due procedure laid down in the relevant election rule 4(3) and (4) of OCS (Elections to the Committees) Rules, 1992.
