Smt. Susamarani Mishra, SARCS, O/o the ARCS, Bhubaneswar Circle is hereby appointed as the Election Officer to conduct the election of office of members of above Constituencies of the Apex Bank Employees Co-operative Credit & Thrift Society Ltd. with a direction to take up the election programme for the said Constituencies by publication of the schedule of election from the stage of filing of nomination so as to

conduct the poll, if necessary, on **Dt.17th September, 2017** by following the due procedure as prescribed in the OCS Act, 1962 & OCS (Elections to the Committees) Rules, 1992 and Circulars/Guidelines issued by this Commission from time to time.

He is also to take up election programme for the post of President and Vice-President thereafter fixing poll date, if necessary, following due procedure laid down in the relevant election rule 4(3) and (4) of OCS (Elections to the Committees) Rules, 1992.
