RESOLUTION

Sub: Re-designation of Lecturers and Readers of Government Secondary Teacher Training Institutions.

Re-designation of Lecturers and Readers of Universities and Colleges of the State has been made vide Higher Education Department Resolution No-7889/HE., dated the 4th April, 2016 . The question of re-designation of Lecturers and Readers of Govt. Secondary Teacher Training Institutions i.e. IASEs/CTEs/TCs has, therefore, become inevitable consequent upon such re-designation. After careful consideration, the State Government have been pleased to re-designate the Lecturers and Readers of Government Secondary Teacher Training Institutions of the State in the following manner:—

1	Lecturer	Rs.15600- 39100/- AGP- Rs.6000/-	Assistant Professor (Stage-I)
2	Lecturer Sr. Scale	Rs.15600- 39100/- AGP- Rs.7000/-	Assistant Professor (Stage-II)
3	Reader [with less than 05 (five)] years of service	Rs.15600- 39100/- AGP- Rs.8000/-	Assistant Professor (Stage-III)
4	Reader [with 05 (five)] years of Service	Rs.15600- 39100/- AGP- Rs.9000/-	Associate Professor

The above re-designation is subject to condition that Lecturers and Readers in receipt of UGC scale of pay shall be posted to such Government Secondary Training Institutions.

The other terms and conditions of Higher Education Department Resolution No.7889/HE., dated the 4th April, 2016 shall apply *mutatis mutandis* for such re-designation.
