**THE ODISHA LEGISLATIVE ASSEMBLY MEMBERS’  
SALARY, ALLOWANCES AND PENSION (AMENDMENT) ACT, 2017**

**AN ACT FURTHER TO AMEND THE ODISHA LEGISLATIVE ASSEMBLY  
MEMBERS’ SALARY, ALLOWANCES AND PENSION ACT, 1954.**

Be it enacted by the Legislature of the State of Odisha in the Sixty-eighth Year of the Republic of India as follows:-

Short title  
and  
commencement.

1. (1) This Act may be called the Odisha Legislative Assembly Members’ Salary, Allowances and Pension (Amendment) Act, 2017.

(2) It shall be deemed to have come into force on the 1<sup>st</sup> day of January, 2017.

section 3.

2. In section 3 of the Odisha Legislative Assembly Members’ Salary, Allowances and Pension Act, 1954 (hereinafter referred to as the principal Act),—

(i) in clause (a), for the words “sixteen thousand

rupees”, the words “thirty five thousand rupees” shall be substituted;

- (ii) in clause (b), for the words “ twenty-four thousand rupees”, the words “forty thousand rupees” shall be substituted; and
- (iii) in clause (c), for the words “twenty-two thousand rupees”, the words “thirty-six thousand rupees” shall be substituted.

3. In section 4 of the principal Act,—

- (i) for clause (a), for the words “ thirteen thousand rupees”, the words “twenty thousand rupees” shall be substituted.
- (ii) in clause (b), --
  - (a) in sub-clause (i), for the words “ eight hundred rupees” the words “ One thousand and five hundred rupees” shall be substituted;
  - (b) in sub-clause (ii), for the words “one thousand rupees” , the words “two thousand rupees” shall be substituted;
- (iii) in clause (c), for the proviso to sub-clause (ii), the following proviso shall be substituted, namely:-
 

"Provided that if a Member performs the journey in his own car or hired car, he shall draw road mileage at the rate of fifteen rupees per kilometer, if the journey is made inside the State and twenty rupees per kilometer, if the journey is made outside the State".
- (iv) in clause (d), for the words “seven thousand rupees”, the words “ fifteen thousand rupees” shall be substituted;
- (v) in clause (e), for the words “one thousand rupees”, the words “ two thousand rupees” shall be substituted;

(vi) in clause (f), for the words “two thousand rupees”, the words “five thousand rupees” shall be substituted; and

(vii) after clause (g) the following clause shall be inserted, namely:-

(h) Accommodation allowance at the rate of one thousand rupees per day till quarters is allotted”.

4. In section 4-A of the principal Act, for the words “eight thousand rupees”, the words “ten thousand rupees” shall be substituted.

5. In section 4-AA of the principal Act, in sub-section(1), for the words “three lakh rupees”, the words “five lakh rupees” shall be substituted.

section 4-B.

6. In section 4-B of the principal Act, in sub-section (1), –

(i) for the figure “2011” and the words “fifteen thousand rupees” occurring in the opening portion, the figure “2017” and the words “thirty thousand rupees” shall, respectively, be substituted;

(ii) in the first proviso, for the words “one thousand rupees” and “thirty-five thousand rupees”, the words “two thousand rupees” and “seventy thousand rupees” shall, respectively, be substituted; and

(iii) in the second proviso, for the figure “2011” and the words “fifteen thousand rupees”, the figure “2017” and the words “thirty thousand rupees” shall, respectively, be substituted.
