ODISHA ACT 18 OF 2017

THE ODISHA MUNICIPAL CORPORATION (SECOND AMENDMENT) ACT, 2017

AN ACT FURTHER TO AMEND THE
ODISHA MUNICIPAL CORPORATION ACT, 2003

Be it enacted by the Legislature of the State of Odisha in the Sixty-eighth Year of the Republic of India as follows:—

Short title.

1. This Act may be called the Odisha Municipal Corporation (Second Amendment) Act, 2017.

Amendment
of section 218.

2. In the Odisha Municipal Corporation Act, 2003 (hereinafter referred to as the principal Act), in section 218, in sub-section (2), for the words "till they attain the age of fifty-eight years", the words "till he attains the age of sixty-five years" shall be substituted.

Amendment
of section 277.

3. In the principal Act, in section 277,—

(a) in sub-section (2), for clauses (c) to (f), the following clause shall be substituted, namely:—

"(c) The Government may, subject to the restrictions and conditions, if any, specify, by notification, from time to time, the financial limit of expenditure involved in the contract to be made by the Commissioner and specify, the financial limit of expenditure involved in a contract where

sanction of the Standing Committee, Corporation or the Government, as the case may be, is required for such contract.”; and

(b) sub-section (3) shall be omitted.

Amendment
of section 279.

4. In the principal Act, in section 279, for sub-section (1), the following sub-section shall be substituted, namely:—

“(1) Any contract or the execution of any work or the supply of any materials or goods which will involve an expenditure exceeding such sum, as the Government may specify, from time to time, the Commissioner shall give notice by advertisement inviting tender for such contract. ”.

Amendment
of section 282.

5. In the principal Act, for section 282, the following section shall be substituted, namely:—

“282. The Government may, subject to the restrictions and conditions, if any, by notification, specify, from time to time, the power of sanction of the amount of estimate of the Commissioner or the Standing Committee on contract or the Corporation or the Government.”.

Omission
of section 283.

6. In the principal Act, section 283 shall be omitted.
