### NOTIFICATION

The 17th November, 2017

**S.R.O. No. 568/2017**— Whereas the draft of certain rules, which the State Government propose to make in exercise of the powers conferred by Section 27 of the Odisha Agricultural Produce Markets Act, 1956 (Odisha Act 3 of 1957), was published in the extraordinary issue No.1258 of the *Odisha Gazette*, dated the 3rd August, 2017 under the notification of the Government of Odisha in the Co-operation Department No. 6631/Coop., dated the 3rd August, 2017 as required under sub-section (4) of the said section, inviting objections and suggestions from all persons likely to be affected thereby till expiry of a period of thirty days from the date of publication of this notification in the *Odisha Gazette*.

And whereas, no objection or suggestion was received from any person in respect of the said draft within the period so specified above by the State Government.

Now, therefore, in exercise of the powers conferred by section 27 of the said Act, the State Government do hereby make the following rules further to amend the Odisha Agricultural Produce Markets Rules, 1958, namely :—

1. (1) These rules may be called the Odisha Agricultural Produce Markets (Amendment) Rules, 2017.

(2) They shall come into force on the date of their publication in the *Odisha Gazette*.

2. In the Odisha Agricultural Produce Markets Rules, 1958 (hereinafter referred to as the said Rule), in rule 41, for sub-rule (2), the following sub-rule shall be substituted, namely :—

“(2) Plan and Estimate for all works, shall be prepared by the Engineering Cell of Board or by the Engineering Cell of the Agency namely, District Rural Development Agency, Panchayat Samiti or other such Government organization or by the Engineering Cell or Office under the Government Department namely, the Works Department, Rural Development Department and Panchayati Raj Department, on recommendation of Market Committee”.

3. In the said Rules, in rule 42,—

(i) for sub-rule (1), the following sub-rule shall be substituted, namely:—

“(1) All construction works of the Market Committee shall be executed under the technical supervision of the Engineering cell of the Board or other such Government organization or by the Engineering Cell or Office under Government Department namely, the Works Department, Rural Development Department and Panchayati Raj Department, as the Market Committee recommended from time to time”; and

(ii) for sub-rule (5), the following sub-rule shall be substituted, namely:—

“(5) Before tenders are invited for the execution of any work, the Engineer-in-charge of the work shall prepare contract documents which shall include :—

- (i) a schedule of quantities of various items of work to be executed and of materials required under each such items; and
- (ii) a set of conditions of contract to be complied with by the tender in case of his tender is accepted”.
