The 27th July, 2018

S.R.O. No. 306/2018— In exercise of the powers conferred by sub-section (1) of Section 9 of the Odisha Goods and Services Tax Act, 2017 (Odisha Act 7 of 2017), the State Government, on the recommendations of the Goods and Services Tax Council, do hereby make the following amendments in the notification of the Government of Odisha in the Finance Department No.19829-FIN-TAX-0022-2017, dated the 29th June, 2017, published in the Extraordinary No. 1133, dated the 29th June, 2017, bearing **S.R.O.No. 295/2017** as amended from time to time and the last such amendment in the notifications of the Government of Odisha in the Finance Department No. 2242-FIN-TAX-0043/2017 dated the 25th January, 2018 published in the Extraordinary issue No. 108 dated the 25th January, 2018 of the *Odisha Gazette* bearing **S.R.O. No. 44/2018**, namely:—

In the said notification, —

(A) in Schedule I-2.5%,—

- (i) after Serial No. 102, the following serial number with its the entries shall be inserted under the appropriate columns, namely:
