NOTIFICATION

S.R.O. No.462/2018— In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Odisha is pleased to make the following rules further to amend the Odisha Fisheries Service, Group 'A' and 'B' (Recruitment and Conditions of Service) Rules, 2013 namely:—

1. (1) These rules may be called Odisha Fisheries Service, Group 'A' and 'B' (Recruitment and Conditions of Service) Amendment Rules, 2018.

(2) They shall come into force on the date of their publication in the *Odisha Gazette*.

2. In the Odisha Fisheries Service, Group 'A' and 'B' (Recruitment and Conditions of Service) Rules, 2013 (hereinafter referred to as the said rules), for sub-rule(1) and sub-rule(2) of rule 5, the following sub-rule shall be substituted, namely:—

“5. (1) The Departmental Promotion Committee for selection of Officer for consideration of promotion to the post of Director of Fisheries in Group-A (Senior Branch) in the service shall consist of the following members, namely:—

- (a) Chief Secretary, Odisha : Chairman
- (b) Principal Secretary/ Commissioner-cum- : Member
Secretary to Government of Fisheries &
A.R.D. Department
- (c) Additional / Joint / Deputy Secretary to : Member Secretary
Government of the Department
(In charge of Fishery Establishment)

(2) The Departmental Promotion Committee for selection of Officer for consideration of promotion to the post as mentioned in clause (ii) to (vi) of sub-rule(2) of rule 3 in Group-A (Senior Branch), the post of Group-'A' (Junior Branch) and Group-'B' in the service shall consist of the following members, namely:—

3. In the said rule, in rule 9, in sub-rule(2), the following sub-rule shall be substituted, namely:—

The Government shall intimate the Commission about the vacancy position to be filled up by way of direct recruitment through Competitive Examination. The Commission after receiving the letter from the Government shall issue advertisement in the leading news papers inviting applications from eligible candidates for appearing in the Examination for selection to the post of Assistant Fisheries Officer in Group-‘B’ service.

4. In the said rule, sub-rule (3) of rule 9 shall be deleted.
